

Seminar for Divorcing Parents Schedule/Information

PRE-REGISTRATION IS REQUIRED

Register AT LEAST 24 HOURS PRIOR to seminar

The seminar is COURT ORDERED and mandatory for all couples that have children 18 years and younger and are seeking a divorce or change in custody in the state of Georgia. The seminar is designed to provide information to assist parents in dealing with the effects of the divorce on the children. Couples DO NOT have to attend the seminar together. Children are NOT allowed in the seminar and childcare will not be provided. Judges will NOT grant a divorce final until both parties have attended the seminar. Interpreters will not be provided by seminar staff; however, the participant can bring their own, with no additional fee.

When registering, you will need the name and phone number of the person attending, names of the plaintiff and defendant, civil action number (if assigned), county where divorce is being filed, and the date and location of the seminar you wish to attend.

\*FEE FOR THE SEMINAR IS \$35.00. NO CHECKS, CREDIT OR DEBIT CARDS PLEASE!! CASH PAYMENT IS DUE AT CHECK IN THE DAY OF THE SEMINAR.

**Albany:** Seminars are held at Porterfield United Methodist Church, 2200 Dawson Road, in the Alpha Classroom. Enter the parking lot from Robinhood Road (Robinhood will be past Lake Loretta from Slappey Blvd end of Dawson Road; before Lake Loretta from opposite direction). Park in the rear of the church where the white buses are located (near the rear of the childcare center and playground). Come in the back door, turn left at the end of the lobby, go to second room on the left.

**Cordele:** Seminars are held at First Baptist Church (main campus), 137 Kelly Road, Cordele, GA 31015

If traveling South on Interstate 75, take the Albany exit (HWY 300), turn right onto HWY 300 and then take an immediate right on Kelly Road. Travel approximately 1 ½ miles to First Baptist Church on the right.

If traveling North on Interstate 75, take the Albany exit (HWY 300), turn left onto HWY 300, crossing over I-75 and take an immediate right on Kelly Road. Travel approximately 1 ½ miles to First Baptist Church on the right.

If traveling East on HWY 300, turn left on Kelly Road just BEFORE crossing over Interstate 75 (DO NOT cross over I-75). Travel approximately 1 ½ miles to First Baptist Church on the right.

**Tifton:** Seminars are held at First United Methodist Church, 107 12<sup>th</sup> Street West, Tifton, GA 31794. (\*Note that this section of 12<sup>th</sup> Street is also known as HWY 41 N).

From I-75 take HWY 41/ABAC exit and go towards town. Go to the third light (church is on the left).

We are on the Northwest corner of West 12<sup>th</sup> Street and Central Ave North (big red brick church).

The Adult Building is the 4<sup>th</sup> building of the main Sanctuary Building (the building with the steeple).

Enter the alley between the Sanctuary Bldg. and the white frame house (Look for a small "Meals on Wheels" sign). Continue down the alley to the fourth building on the right. Park anywhere along that sidewalk and enter the building from that parking lot, door in rear on the side of building.
